Dingoes on K'gari

The dingo pack linked to the death of Canadian tourist Piper James on K'gari (previously known as Fraser Island) have been destroyed, the Queensland government has announced.

Queensland Environment minister Andrew Powell has confirmed that an entire pack of 10 animals were euthanised.

The group were linked to the death of Piper James, 19, on the 19th of January. An autopsy found physical evidence consistent with drowning and injuries consistent with dingo bites, but "pre-mortem dingo bite marks" were "not likely to have caused immediate death".

The island is home to an estimated 200 dingoes, which are sacred to the Indigenous Butchulla people, who call them Wongari, and are specifically mentioned in K'gari's world heritage listing. "This tragedy has deeply affected Queenslanders and touched the hearts of people around the world," Powell said in a statement in relation to Piper's death.

A spokesperson for the Environment department said rangers had spent the week closely monitoring the pack of dingoes involved in the incident and observed aggressive behaviour. They were deemed an "unacceptable public safety risk". (Source: The Guardian.com)
