

Privacy Policy

Woodford Livestock and Property recognise the importance of protecting the privacy of information collected about visitors to our sites, in particular information that can identify an individual ("personal information"). This document is our privacy policy, and it tells you how we collect and manage your personal information.

Collection of your Personal Information

We refer to personal information as which your identity is reasonably apparent. How We Collect Personal Information

You should be aware that we and authorised may use your email address to contact you in the future. We will not sell or pass on your details to third parties.

Correcting Information

You may request at any time the information we have collected about you be corrected or deleted. This is our commitment to take all reasonable steps to ensure that the information we store/archive is accurate.

Whom We May Disclose Your Information ?

We may disclose your personal information to –

Woodford Livestock and Property employees, contractors, employees or service providers for the purpose of the operation of our websites, Suppliers and other third parties with whom we have a commercial relationship for business and marketing.

We will only do this in the following circumstances –

- You have consented
- Where this is directly related to the primary purpose
- Where we are permitted or required by law or it is in the interests of public safety

Disclosure

We may use your email address or mobile phone number to contact you in the future. We will not sell or pass on your details to third parties.

Security

Woodford Livestock and Property use all reasonable efforts to ensure the security of your personal information is kept confidential.
